TERMS & CONDITIONS

"Caterer" - Lamars Food Services

"Client" - individual/company stated on the Service Agreement Contract

Miscellaneous Charges

- a) Holiday Charges. Should the event fall on a holiday, a Holiday Fee of Php5,000.00 or 10% of the Package Price, whichever is higher, will be charged on top of the Package Price.
- b) Mobilization Charges*. Should the event venue be held in Greater Metro Manila or farther, a Mobilization Fee will be charged.**
- c) Last Minute Guest Count Changes. Clients are encouraged to finalize the guest count 3 days before the event. Any guest additions later than 72 hours before the event will be charged 20% on top of the published price per head. Any decrease in guest headcount following the contract signing will not affect the agreed upon Total Contract Price, event set-up and food quantity.

Cash Bond & Incidental Charges (non-corporate events)

Cash Bond. We will be requiring a Php5,000.00 or 10% of the Package Price, whichever is higher, as a Cash Bond Deposit should there be any of the following event-related incidences. This is to be deposited on the same day as the Final Balance. Balance will be returned 3 business days following the event via bank transfer. Incidental Charges are:

- a) Third-Party Food Handling Charge. Any service/equipment that is not included in the Basic Wedding Amenities will have a corresponding charge. This includes lechon table, chopping & distribution, extra plates for outside food, glasses for outside drinks, etc.
- b) Subdivision/Building Gate Entrance Fees*. Entrance fees charged by the venue or the subdivision of the venue.
- c) Extended Service Charge. Should the event duration exceed the allotted 5 hours, Caterer will charge Php100/waiter/hour of extension.
- d) Staircase Charge. Should the event be held in a non-ground floor venue and the facility does not have a functioning elevator, a charge of Php50/floor/waiter will be charged.
- e) Damage Fees. Should a guest damage/break any service equipment, corresponding equipment fee will be charged.**
*will be billed 3 business days following the event proper.

Payment Terms

- a) Payment Details and Terms as provided in the contract will be duly accomplished and abide by its given schedule.
- b) All payments may be in cash, personal check or bank transfer. All non-cash payments shall be made out/transferred to:

(Personal Events)

- c) Reservation Fee. Php10,000.00 to be paid upon signing the contract to block off the event date.
The Reservation Fee is non-refundable and non-transferable but deductible from the Total Contract Price.
- d) Downpayment. 50% of the Total Contract Price, to be paid a month before the event date. Should there be a cancellation, the downpayment is consumable within a year following the event date.
- e) Final Balance. To be paid 7 days before the event date.

(Government/Corporate Events)

- c) Payment Terms and Schedule will strictly be followed. Any delay in payment will result in a Late Fee which is 10% of the Total Contract Price.
- d) Document Requirements needed by the Client/Company/Office from the Caterer for payment processing (ie. Business Permit, TIN, etc) shall be notified IN WRITING, to be submitted alongside signed Service Agreement Contract.

Food & Drink Liability

- a) Excess Number of Guests. Caterer will not be held liable for any food or beverage shortages that will arise due to exceeding the number of reserved guests.
- b) Leftovers. Caterer reserves the right to discard any leftover food items after the agreed upon event duration. Should the Client choose to take home leftover food, a liability waiver shall be signed by the Client freeing the Caterer of any responsibility of food spoilage following the event proper.
- c) Outside Food. A liability waiver shall be signed prior to the event should there be any foods/beverages served provided by a Third Party NOT associated with the Caterer. This will free the Caterer of any responsibility should there be an incident of Food Poisoning during or immediately after the event.

Venue

- a) Permits. Client shall secure any and all permits, authorizations, clearances and/or licenses from any governmental authority required for the Event. Client shall inform Caterer of all gate pass/entrance requirements to allow venue entry and set-up at least 7 days prior to the event date. Client shall ensure Caterer entry to the Venue. Caterer will not be held liable for delayed set-up/service due to restricted entry by the venue.
- b) Ingress. Client must guarantee Caterer use of venue for at least 5 hours during the ingress period. Caterer will not be held liable for any set-up delay due to shortened ingress times.

Force Majeure

- a) The Caterer shall not be held liable for any failure or delay in the performance of any of its obligations under this Contract if such failure or delay is caused by force majeure.
- b) In case of force majeure 24 hours before the event, Client may reschedule the event to a future date. In case of force majeure less than 24 hours before the event, client will be refunded 50% of the total contract price.
